



## The Next Chapter Starts Here: \$INSIDERS Presale

Due to unforeseen circumstances, we had to rebuild \$INS with deep, locked liquidity and a fair structure that honours legacy holders. This is not a new token. It's the same movement — now unchained and built for global scale on BASE.

### Why a BASE-Chain Presale?

The previous version of \$INS was tied to a rigid ecosystem that restricted how liquidity, token flow, and utility could evolve. The presale is a **clean, transparent path forward** that focuses on the following:

- **Real Liquidity.** 100% of presale funds is locked as liquidity pool for 12 months
- **Suitable Target Market.** As \$INS mission begins with mainly US TradFi markets, BASE being more US-centric would match the target audience needed.
- **Enabling Long-Term Growth.** Marketing funds for essential next steps — CEX listings, development, analytics, and visibility
- **Launches Fairly.** Every token is vested, no instant dumps, no private advantages
- **Protects Legacy Holders.** Legacy holders in the Migration Snapshot can redeem their new \$INS tokens 1-for-1 — nothing changes except now; it has room to grow.

### Legacy Holders Migration

Only for the first 800 million tokens; priority will be given to current holders based on a snapshot done before the 19<sup>th</sup> May 2025 announcement. Tokens were sent to the:

Any unsubmitted Legacy tokens from the 800 million tokens **will be burned** when \$INS relaunches. We will drain the remaining liquidity in the migration wallet and **use the remaining funds and support the Presale**. Presale \$INS Tokens obtained from the migration wallet purchase **will be burned**.

- *Legacy tokens will be honoured 1:1 and claimable following the vesting schedule as Presale participants (10% at launch, 10% weekly vesting)*
- *Legacy migration process has passed and the total Legacy Tokens migrated is 696,327,559 & 103,672,441 unsubmitted Legacy tokens to be burned.*

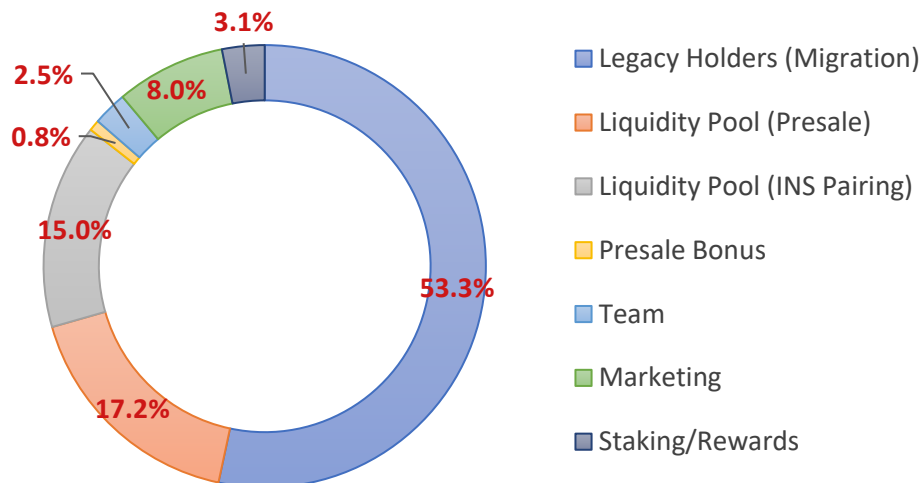
